Notes to Parking Charges:

Maximum 90 minutes parking charge for aircraft arriving and departing between 24:00 and 05:00

Maximum 3 hours parking charge for day stops (05:00 until 24:00) for aircraft (excluding cargo aircraft) that perform long-haul scheduled flights (flight time of more than 4 ½ hours).
